FIRST AMENDMENT TO CITY OF NIEDERWALD ORDINANCE NO. 20220411A

This First Amendment to City of Niederwald Ordinance No. 20220411A ("First Amendment") is entered into and becomes effective on this <u>J44</u> day of <u>October</u>, 2024, by and between Camino Real Utility Company LLC, a Texas limited liability Company, and Spanish Trail Utility Company LLC, a Texas limited liability Company (collectively, the "Companies") and City of Niederwald (the "City").

RECITALS

WHEREAS, **Camino Real Utility Company LLC** and **City of Niederwald** previously entered into Ordinance No. 20220411A, passed by the City Council of Niederwald, with an effective date of April 12, 2022, a copy of which is attached hereto as <u>Attachment 1</u> ("Original Ordinance").

WHEREAS, Camino Real Utility Company LLC and the City of Niederwald now wish to include Spanish Trail Utility Company LLC to the Original Ordinance and therefore desire to enter into this First Amendment to reflect that inclusion.

FIRST AMENDMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the **Companies** and the **City** agree as follows:

- 1. Statement of Purpose. Notwithstanding the terms and conditions of the Original Ordinance, the City herby includes Spanish Trail Utility Company LLC in this Ordinance, granting the existing rights, privileges, and franchise as previously granted to Camino Real Utility Company LLC under the Original Ordinance.
- 2. Grant of Authority. Notwithstanding the terms, conditions, and provisions of this ordinance and other applicable state, federal, and local laws and regulations, the City shall extend the right, privilege, and franchise to Spanish Trail Utility Company LLC.
- 3. **Definitions**. Item B. of Section 2 of the Original Ordinance is deleted and replaced as follows:

B. "Companies" shall mean Camino Real Utility Company LLC, a Texas limited liability company, and Spanish Trail Utility Company LLC, a Texas limited liability company. The term "Companies" shall not mean any of its affiliates and subsidiaries who shall have no right, privilege, or franchise granted hereunder.

4. Any reference to "**Company**" in any section of this Original Ordinance shall be interpreted and constructed as "**Companies**".


