ORDINANCE NO. 012605-C

AN ORDINANCE PROVIDING FOR THE REPEAL OF A MORATORIUM ON THE APPLICATION FOR, RECEIPT, PROCESSING, CONSIDERATION, APPROVAL, AND/OR ISSUANCE OF SUBDIVISION PLATS, AND ANY VARIANCES THERETO; PROVIDING FOR A SAVINGS CLAUSE AND REPEALING CONFLICTING ORDINANCES OR RESOLUTIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Niederwald is a Type A general-law municipality; and

WHEREAS, a moratorium, and an extension of the moratorium, was previously imposed by the City Council on the application for, receipt, processing, consideration, approval, and/or issuance of subdivision plats, zoning change requests, and any variances thereto in order to allow the City Council to temporarily maintain the status quo of the City while it contemplated changes to the City's development regulations to address concerns over its future welfare; and

WHEREAS, the City Council of the City of Niederwald, Texas desires to adopt this Ordinance in order to repeal the moratorium on the application for, receipt, processing, consideration, approval, and/or issuance of subdivision plats, and any variances thereto; and

WHEREAS, the City of Niederwald, Texas, has prepared an ordinance amending the City's Subdivision Ordinance; and

WHEREAS, the City Council desires that the repeal of the moratorium on the application for, receipt, processing, consideration, approval, and/or issuance of subdivision plats, and any variances thereto, shall be effective only when the amendments to the Subdivision Ordinance become effective;

WHEREAS, the City Council desires to retain the moratorium on zoning change requests, as previously extended until April 14, 2005, therefore this Ordinance does not affect the current moratorium on zoning change requests; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NIEDERWALD, TEXAS, THAT:

I.

The moratorium enacted by and described in Ordinance No. 081604 imposing a one hundred and twenty (120) day moratorium on the application for, receipt, processing, consideration, approval, or issuance of subdivision plats (including conceptual plans and preliminary plats), and further extended by Ordinance No. 121404-4, is hereby repealed. This Ordinance shall not alter or affect the existing moratorium on the application for,

receipt, processing, consideration, approval, or issuance of zoning change requests, requests for variances, special exceptions, and conditional uses allowed by the provisions of the City of Niederwald's Zoning Ordinance, said moratorium to be effective until April 14, 2005, subject to further action of the City Council.

II.

The repeal of the moratorium on the application for, receipt, processing, consideration, approval, or issuance of subdivision plats (including conceptual plans and preliminary plats), and any variances thereto, shall take effect at the same time that the amendments to the City of Niederwald Subdivision Ordinance, contained in Ordinance No. <u>0/2605-A</u> adopted on January 26, 2005, become effective. Every officer, employee, or agent of the City of Niederwald is hereby prohibited from receiving, processing, considering, approving, and/or issuing subdivision plats (including conceptual plans and preliminary plats), or requests for variances related thereto, until the repeal of the moratorium takes effect pursuant to the provisions contained herein.

III.

A. All ordinances, parts of ordinances, or resolutions in conflict herewith are expressly repealed.

B. The invalidity of any section or provision of this Ordinance shall not invalidate other sections or provisions thereof.

IV.


