Agenda Item 2. Discussion and possible action regarding a subdivision at 700 Marks Way.

Synopsis: The City received a request to subdivide land located at 700 Marks Way in Kai Vista Estates, Section 1, Hays County, Texas. The lots proposed have 124.88 and 124.9 feet of frontage. The subdivision does not meet the City's requirements of 125 feet of frontage on a public road per the City's Subdivision Ordinances. There was not a variance filed to consider approval.

Agenda Item 3. Discussion and possible action regarding a Final Replat for Goforth Reserve Tract, Angel Hill Subdivision.

Synopsis: Goforth Special Utility District filed a replat with the city for combining two adjacent lots into one. The lots are located in the Angel Hill Subdivision. The first lot consist of .412 acre and the second lot consist of .330 acre for a combined .742 acre tract. Goforth is requesting to combine these tracts to better serve the Angel Hill Subdivision.

Agenda Item 4. Discussion and possible action to approve Final Plat for Prairie Lakes Subdivision 2-1 and 2-2.

Synopsis: BGE, Inc. submitted final plats for Prairie Lakes Phase 2, Sections 1 and 2. Both sections are in the Z. Hinton Survey, Abstract No. 219, Hays County. Section 1 consists of 25.312 acres of land and Section 2 consists of 35.961 acres. Sara Montgomery informed the Council that according to the Development Agreement the permits for these sections would be filed with the City of Niederwald even though a portion of the land is in the ETJ. Mayor Bisson confirmed that the City has received approval by the City Engineer.

Richard Crandal stated that inspection fees have gone up 24 percent since the last schedule was created.

Agenda Item 10. Report on city operations and activities by City Administrator

Synopsis: City Administrator has been working on Camino Real project, 700 Marks Way Subdivision, a new subdivision on Appaloosa Drive and possibly a new subdivision on Schubert Lane. Sara advised

the Council that the Prairie Lakes Commercial/Mixed-Use developers are still working on an amendment to the Prairie Lakes Development Agreement to include Townhomes as an acceptable use in the Commercial/Mixed-Use. The City is currently still waiting on the revised plat for the 6301 Niederwald Strasse Property. Sara and Richard had a meeting with Brohn Homes and the City Engineer regarding the Development Agreement for the Bluestem Subdivision. Sara advised the Council that the Gini Lane repairs exceed the \$50,000.00 because of the road failure. Due to this, the City will need to go through a bidding process, which will require an Engineer to present a design standard for the road. Sara also stated that she had been working on Las Estancias building permits and expired permit fees.
